Goals

1. Sustain safe and healthy schools
2. Position CPSD for a return to normal activities in the fall of 2021
3. Safely return students and school personnel to school in the fall of 2021
4. Provide social and emotional support for students in all schools
5. Sustain the district's academic standards to ensure student achievement

DAILY PROCEDURES

1. It is imperative for parents to screen their child's health on a daily basis.
 - Parents should screen for the following symptoms:
 - Fever 100.4 or higher
 - Cold and flulike Symptoms
 - Gastrointestinal problems
 - Unexplained or persistent cough
2. Upon entering the school building, students will report to their homeroom teacher and have their temperature measured with a temporal scanner.
3. Students exhibiting any symptom of illness will be required to go home.
 - Fever 100.4 degrees or higher
 - Shortness of breath or difficulty breathing
 - Unexplained or persistent cough
 - Gastrointestinal problems
4. Any student sent home for illness must be free from any fever for 24 hours without medication.
5. Signage will be placed throughout all CPSD campuses reminding students and personnel of best health and safety practices, including hand hygiene.
6. Hand sanitizer will be provided by the district to every teacher as well as placed throughout buildings for easy access and use.
7. Classrooms will be arranged in a manner to ensure students are as socially distanced as space will allow.
8. Masks will be optional for all faculty, staff, students and visitors inside CPSD buildings. The superintendent may require masks for all faculty, staff and students if local health data dictates a need to do so.
9. Breakfast and lunch will be provided by CPSD Child Nutrition. Alternate serving methods may be used if necessary, to enable all students to have access to meals while complying with health guidelines. Methods may include serving meals in the cafeteria or inside classrooms or hallways.

BUS TRANSPORTATION

1. All drivers will be equipped with proper Personal Protective Equipment (PPE) to ensure their safety and the safety of riders.
2. Students will sit in assigned seats on the bus.
3. Buses will be thoroughly cleaned between and after routes.
4. Buses will be disinfected twice daily using an electrostatic sanitizer.
5. Masks will be required to be worn by all riders through the duration of the route.

HEALTH & SAFETY

1. Masks will be optional for all faculty, staff, students and visitors inside CPSD buildings. The superintendent may require masks for all faculty, staff and students if local health data dictates a need to do so.
2. Signage will be placed throughout all CPSD campuses reminding students and personnel of best health and safety practices, including hand hygiene.
3. Hand sanitizer will be provided by the district to every teacher and placed throughout buildings for easy access and use.
4. All buildings will have particle ionization units installed in all HVAC systems.
5. Classrooms will be arranged in a manner to ensure students are as socially distanced as space will allow.
6. Protocols have been put in place for facilities impacted by COVID-19.
7. Buildings will be cleaned and sanitized regularly throughout the day.
8. Any student exhibiting symptoms will be asked to go home immediately.
9. Any student sent home for illness must be free from any fever for 24 hours without medication.
10. Any student displaying symptoms of COVID-19 will be issued a mask to wear until a parent or guardian arrives to pick up their student. This mask will be required to remain on until student has exited the building.
11. Upon a positive COVID-19 test result, parents are strongly urged to contact their child's principal immediately.
12. Upon a positive COVID-19 test result, parents of children who have come into contact with a confirmed positive case will be contacted by the school.
13. Contact tracing will be used to identify students who have been in close contact with any confirmed positive cases.

INSTRUCTION

1. All grade levels will utilize Canvas for instruction.
2. Virtual instruction will be available only to students who show a specific medical need and must be under the care of a physician. Medical documentation must also be provided by a physician.

3. Social and emotional learning instruction will be provided to all students. Any student requiring additional support will be referred to the School Support Team.

VISITORS

1. Nonessential visitors will be limited and seen by appointment only.
2. Lunch guests will not be permitted.
3. Only Essential vendors will be allowed on campus and will be seen by appointment only.

COMMUNICATION

1. All news and information will be available on the Clinton Public School District's website, through Twitter (@ClintonSchools) as well as through traditional media.
2. CPSD will utilize Canvas and SchoolStatus for mass communication with parents and students.

TECHNOLOGY

1. Clinton is a 1-to-1 district providing each student with his or her own Apple device.
2. All grade levels will utilize Canvas for instruction.

ATHLETICS & EXTRACURRICULARS

1. All Clinton activities and athletics will follow all MHSAA and MDE recommendations for events, activities, performances and competitions.
2. Arrow Athletics will utilize the NFHS Network to live stream athletic events.
3. Arrow Athletics will utilize GoFan Cashless Ticketing App.
4. Virtual students forfeit their opportunity in extracurricular activity participation.
